Functional Assessment

- Medicaid Functional Eligibility Instrument (MFEI) update
 - Kansas adapted the interRAI-Home Care (iHC) tool
 - Developed in partnership with KU researchers and WSU technical team
 - Stakeholder Advisory Groups (2)
 - Diverse representation
 - Replaces the FAI for FE, PD and TBI waivers and eventually the BASIS for I/DD

The HCBS Team conducted a thorough review of allowed use of restrictive interventions, including restraint and seclusion. Currently the IDD waiver allows for restrictive interventions, seclusion, and restraint under certain conditions; use of such interventions must be reported to the State's Adverse Incident Reporting System (AIRS). Such restrictive interventions are not permitted in the FE, PD, and TBI Waivers.

Appendix G: Restraint, Seclusion

Statutory Requirements

- Updates to reflect all relevant Federal and state requirements.

Least Restrictive

- Requires least restrictive intervention
- Prescribes prohibited uses

Compliance

- Addresses staff qualifications & training
- State compliance monitoring

Waiver Performance Measures Overview

2017

- **CMS Corrective Action Plan (CAP)**
- **Kansas Advocates Network (KAN), including KACIL and Interhab, proposed a list of 30 metrics for HCBS Quality Measurement**

2018

- **Compared metrics to current and planned measures**
- **Requested KAN feedback on priority level and KDADS planned changes**

Future

- **Share results on priority measures, as they are available**
- **Implement additional quality measures and surveys, as needed**
- **Incorporate efforts into Meaningful Measures Collaborative**

Person-Centered Service Plan

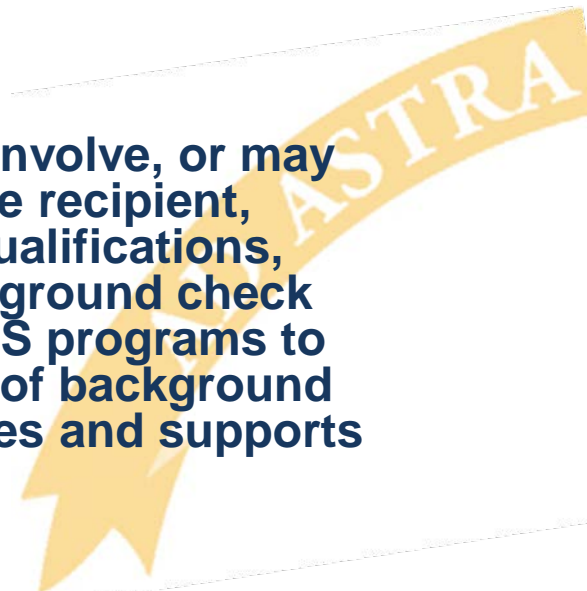
The purpose of this policy is to explain the Person-Centered Service Plan requirements found in HCBS Final Settings Rule.

HCBS Institutional Transitions

This policy establishes the process and procedures for requesting, managing and determining eligibility for individuals in Medicaid approved institutional settings to transition into the community and onto HCBS waivers services.

Background Checks

To be a qualified HCBS provider of services that involve, or may involve one-on-one contact with the HCBS service recipient, individuals and entities shall meet the provider qualifications, including passing a background check. The background check requirements have been standardized for all HCBS programs to ensure consistency, efficiency and effectiveness of background checks for individuals receiving long-term services and supports through HCBS programs.

Grievances and Appeals

- MCO processes must adhere to federal and state requirements

Capable Persons

- Personal care services and limitations policy effective 2/1/16 with final revisions completed on 11/30/16

Network Adequacy

- Provider Enrollment Practices
- Monitoring network adequacy

Service Limitation

- Clear process for how service limitations are determined and how exceptions are requested

PD Services/Waiver Updates

- No changes to PD services have been identified at this time.
- Waiver updates will primarily focus on updating policy references and correcting grammatical and spelling errors.



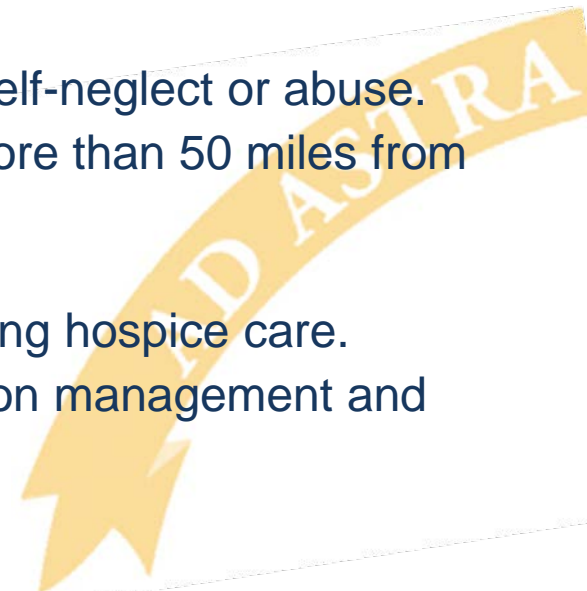
Frail Elderly (FE) Waiver

Overview of proposed changes



FE Services/Waiver Updates

- Enhanced Care Services Crisis Criteria
 - Make service more accessible to FE waiver participants
 - Change crisis exception process from meeting 5 out of 6 criteria to 4 out of 6.
 - Lacks family or friends within close proximity to provide informal supports.
 - Has Adult Protective Service confirmation of self-neglect or abuse.
 - Lives in a rural or frontier area that is either more than 50 miles from any provider or the participant lives alone.
 - Has a severe cognitive impairment.
 - Is in the end stages of an illness and is receiving hospice care.
 - Scores a “4” in toileting, transferring, medication management and treatment, and walking and mobility.



Traumatic Brain Injury (TBI) Waiver

Overview of proposed changes



TBI Waiver to Include Acquired Brain Injury and Children

- Legislative Proviso expands TBI Waiver to Include Acquired Brain Injuries and Children under age 16
- Stakeholders have begun work on redefining eligibility for the Brain Injury Waiver
- Reviewing criteria for Assistive Services, developing a crisis exception policy, identifying a pediatric assessment tool, reviewing current services

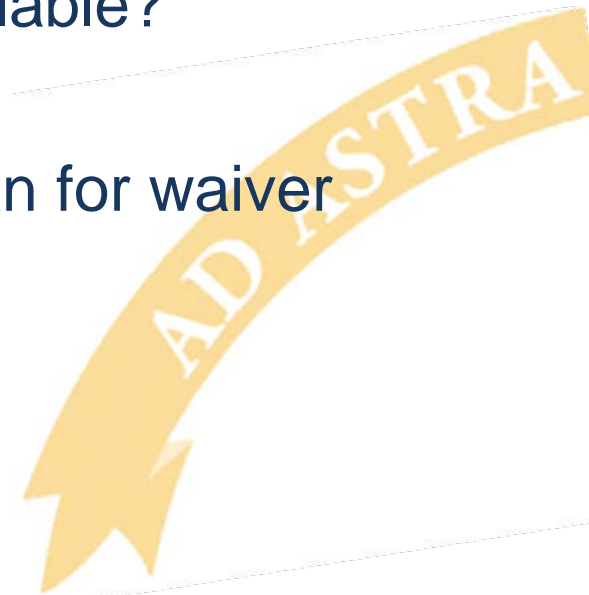
IDD Services/Waiver Updates
