**7) To obtain a Kansas Certificate of Tax Clearance:**

- Go to <http://www.ksrevenue.org/taxclearance.html> to request a Tax Clearance online.
- Return to the website the next day to see if KDOR has issued a Certificate.
- When issued your official Certificate of Tax Clearance, save the document, and print it.
- The Certificate is valid for 30 days from the date it was issued.
- If denied a certificate, contact the Kansas Department of Revenue, office of the Director of Taxation about why a certificate wasn't issued and what actions may need to be taken.
- Note: Kansas Tax Clearance is not the same as IRS tax-exempt status.
