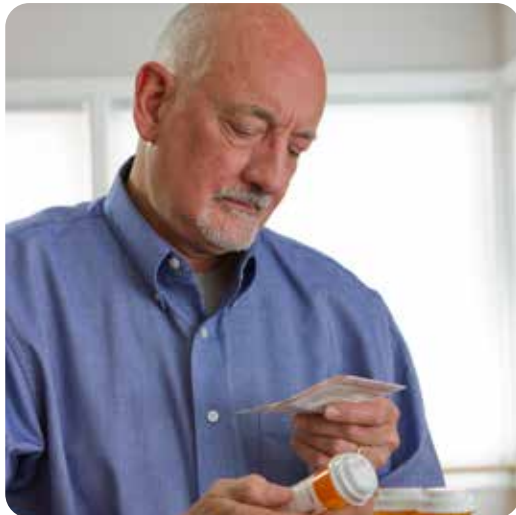


**SHICK counseling is free, unbiased, confidential and available to anyone with questions about Medicare.**

## Senior Health Insurance Counseling for Kansas (SHICK)

People with Medicare often have questions about health insurance but frequently they have limited resources to obtain objective information.

To address these needs, Congress created the State Health Insurance Assistance Programs (SHIPs). There is a SHIP in every state as well as Guam, Puerto Rico, the Virgin Islands and the District of Columbia. Senior Health Insurance Counseling for Kansas (SHICK) is the SHIP in Kansas, and is administered by the Kansas Department for Aging and Disability Services.

SHICK is a free, unbiased and confidential program that employs trained community counselors to answer questions about Medicare and other insurance issues.

### Mission

SHICK educates the public and assists consumers on topics related to Medicare and health insurance so they can make informed decisions.

## One-on-One Counseling

SHICK counselors receive training on all aspects of Medicare and other health insurance topics that concern Kansans. Counselors are available to meet with consumers for personalized counseling sessions, help with problems and questions, and provide support during the decision-making process. SHICK counselors will not recommend policies, companies or agents but will provide free, unbiased answers to the questions of consumers, their family members, and other caregivers.

The goal of our counselors is to educate and assist the public in making informed decisions about their health care options.

## Information and Education

An important role of the SHICK program is to provide outreach and education regarding health insurance options, benefits and choices. SHICK counselors and staff are available at the local, regional and statewide level. Counselors participate in a variety of outreach activities, including media awareness, public presentations and enrollment events.
